SUPPLEMENT to the STANDARD SAILING INSTRUCTIONS (SSI) (Numbering corresponds to the RRS Appendix S)

The notation '[NP]' in a rule of the supplemental sailing instructions (SSIs) means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

3 COMMUNICATIONS WITH COMPETITORS

- 3.1 The online official notice board is located at https://pcyc.net/WOW-Regatta. Failure to post a notice on the website will not be grounds for redress under RRS 60.1(b).
- On the water, the race committee may make courtesy broadcasts to competitors on VHF radio 71.
- 3.3 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

5 SIGNALS MADE ASHORE

- 5.1 Signals made ashore will be displayed at the flag pole located south of the back of the Clubhouse.
- 5.2 When flag AP is displayed ashore, '1 minute' is replaced with 'not less than 45 minutes' in Race Signals AP.

6 SCHEDULE

6.1 The schedule for the event is:

Time 1200

Skipper's Meeting 1200 First Warning Signal 1245

> Subsequent races to follow No Warning Signal after 1500

Awards To be held as soon as is feasible after racing

6.2 A maximum of four races will be held.

7 CLASS FLAG

7.1 Division Flags will be posted on the online official notice board by 0900 Sunday, August 22nd.

8 RACE AREA

- 8.1 Racing will take place south of the entrance to the Port Credit Yacht Club basin.
- 8.2 The location of the race course is at the discretion of the Race Officer and is not grounds for redress.

9 COURSES

9.1 The diagram below shows the course, including the approximate angles between legs, the order in which marks are to be passed, and the side on which each mark is to be left.

10 MARKS

- 10.1 The marks used will be inflatable marks.
- 10.2 The mark colours will be:

Start/Finish Green
1, 2 and 3 Yellow
Change of Course Orange

15 TIME LIMITS [AND TARGET TIMES]

15.1 The Mark 1 Time Limit, Race Time Limit (see RRS 35), and the Finishing Window are shown in the table below.

Mark 1 Time Limit	Race Time Limit	Finishing Window
20	60	10

- 15.2 If no boat has passed the first mark within the Mark 1 Time Limit, the race will be abandoned.
- 15.3 The Finishing Window is the time for boats to finish after the first boat sails the course and finishes. Boats failing to finish within the Finishing Window, and not subsequently retiring, penalized or given redress, will be scored Time Limit Expired (TLE) without a hearing. A boat scored TLE shall be scored points for the finishing place [one][two] more than the points scored by the last boat that finished within the Finishing Window. This changes RRS 35, A5.1, A5.2 and A10.
- 15.4 Failure to meet the Target Time will not be grounds for redress. This changes RRS 62.1(a).

16 HEARING REQUESTS

- 16.1 The protest time limit is 60 minutes after the docking time of the signal vessel. The time will be posted on the official notice board.
- 16.2 Hearing request forms are available online at https://pcyc.net/WOW-Regatta and at the Communications Centre.
- 16.3 Notices will be posted no later than 30 minutes after the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearings will be held on the veranda of the Learn to Sail building.

18 SAFETY REGULATIONS

18.1 [DP] A boat that retires from a race shall notify the race committee at the first reasonable opportunity.
